PRODUCT INFORMATION

Fat Free Evaporated Milk is the liquid food obtained by the partial removal of water only from skim milk. It contains not less than 20% by weight of total solids and not more than 0.5% by weight of milk fat unless otherwise indicated. Fat Free Evaporated milk contains added vitamins A and D. It is homogenized and sealed in a container. Product meets a minimum public health cook and is commercially sterile in compliance with U.S. CFR Title 21 Part 113.

Ingredients: Skim Milk, Vitamin A Palmitate, and Vitamin D₃.

SHELF LIFE & STORAGE

Product should be stored under clean, dry, normal warehouse conditions.

Optimum Shelf Life is 9 months. Protect from freezing and temperatures above 90 degrees F.

ALLERGENS

Product contains milk.

Product <u>does not</u> contain added components of the following allergens: Cereals containing gluten, crustaceans, eggs, fish, peanuts, soybeans or nuts.

Product is Gluten Free.
