Filled Evaporated Milk is a prepared blend of skim milk, vegetable oil, stabilizers, and vitamins. It is homogenized and sealed in a container. Product meets a minimum public health cook and is commercially sterile in compliance with U.S. CFR Title 21 Part 113.

Ingredients: Fat Free Milk, fully refined Soybean Oil, Soy Lecithin, Disodium Phosphate, Carrageenan, Vitamin A Palmitate, and Vitamin  $D_2$ .

### SHELF LIFE & STORAGE

Product should be stored under clean, dry, normal warehouse conditions.

Optimum Shelf Life is 1 year. Protect from freezing and temperatures above 90 degrees F. Refrigerate unused portion after opening.

#### **ALLERGENS**

Product contains milk and soy ingredients.

Product <u>does not</u> contain added components of the following allergens: Cereals containing gluten, crustaceans, eggs, fish, peanuts, or nuts.

Product is Gluten Free.

#### **SDS**
